Dear Parent/Carer

KS3 PSHE/RSHE 2023/24

I am writing to inform you that as part of our wider curriculum offer, all students at CCHS in years 7-9 receive a Personal, Social, Health and Economic Education (PSHE) lesson every fortnight that is timetabled into their curriculum. In Year 7 and 8, our Relationships and Sexual Health Education (RSHE) curriculum content is covered through our PSHE programme of delivery. In Year 9, students have two focused RSHE lessons that are delivered through a floating timetable and delivered by a subject specialist. During these lessons, students will be taught RSHE instead of their usual timetabled lesson. Our curriculum approach and delivery ensures that as a school we effectively deliver the statutory requirements for PSHE and also RSHE within school, and that we also meet the needs of our students and community.

Each year group has a bespoke curriculum and is another opportunity for students to acquire information, develop skills and positive beliefs, values and attitudes with regards to healthy relationships and sex. The lessons are taught at an age appropriate level, in a safe environment where students can ask questions, and ultimately be equipped to live safe, fulfilled and healthy lives.

These sessions will also promote the spiritual, moral, cultural, emotional and physical development of students at the school and of society, and will endeavour to prepare students for the opportunities, responsibilities and experiences of later life.

Parents right to withdraw

Requests for withdrawal should be put in writing and addressed to the headteacher.

A copy of withdrawal requests will be placed in the student's educational record. The headteacher will discuss the request with parents and take appropriate action.

Students who are withdrawn from RSHE will work in the RESET room during this time, and be provided with a reading book, if they have not brought their own, to read during this lesson.

For requests concerning the withdrawal of a student with SEND, the headteacher will take the student's specific needs into account when making their decision.
