#### Mission, Vision & Values

#### Mission

To be "Greater Than The Sum Of Its Parts" represents the mission statement for The Sigma Trust. We believe we are stronger and more successful working together than we would be as separate institutions. The Greek letter Sigma ( $\Sigma$ ) is used in Maths and IT to denote "the sum of" hence its adoption as our name.

The mission for each academy within The Sigma Trust is to ensure that no child is left behind. Education should foster in its learners a curiosity to discover who they are and what they are capable of, together with developing the resilience for them to test the boundaries of their abilities, and build the skills necessary to face the future with confidence.

#### Vision

Our vision is to ensure that all of our academies are at least "Good" and are able to demonstrate some outstanding provision. We will achieve this by:

- Growing a local family of academies that fully embraces the mission, vision and values of the Trust.
- Creating a centre of educational excellence in the area in which best practice becomes shared practice so that no school is left behind
- Recognising and celebrating the uniqueness and achievements of each academy.
- Ensuring that every school is a giver and receiver of support
- Developing a relationship where autonomy and accountability go hand in hand
- Working in collaboration with other institutions rather than in isolation
- Training, recruiting and retaining teachers, leaders and support staff through high quality career development
- Requiring that services are delivered efficiently and represent outstanding value for money.

#### **Values**

The Sigma Trust has the following values at its heart:

- Integrity to be honest, transparent, trustworthy and true to your beliefs
- Passion to be positive and enthusiastic about what you are trying to achieve
- Aspiration to aim for your best and set high, realistic goals
- Resilience to never give up and strive to improve
- Respect for yourself, your environment and other people
- Accountability to take responsibility for your words, thoughts and actions

Applicants to become a member of a Local Governance Committee (LGC) of any Sigma Trust Academy should be aware that, under the relevant articles of association, an LGC is actually a sub-committee of the Board of Trustees for Sigma. It is the Trust which has the final determination as to whether or not to appoint an applicant as a local governor and, should the Board decide not to make or confirm an appointment, it will not reveal the reasons for making that decision. Sigma seeks to balance the knowledge, skills and experience of its LGCs and this is the most likely reason for an individual's application not being supported.

The Trust can, at any time, dismiss an individual Local Governor or, indeed, the full Local Governance Committee, and is not required to explain its reasons for so doing. It is, of course, the wish of Sigma to be



working in partnership to try to ensure that the Trust never has to invoke these powers at any of its academies.

Sigma takes very seriously its responsibilities to safeguard the children in the school. The current appointment process, which meets the standards expected by the Department for Education, requires newly appointed Local Governors to produce evidence of identity (e.g. a passport or photo driving licences) at their first meeting. A check is then made against the DfE's List 99 which is the register of persons barred from working with children. We will also follow up your references. Certain people are disqualified from governorship. New Local Governors are also sent a disclosure form when their appointment is confirmed as they will be asked by the school to undergo a DBS (Disclosure & Barring service) check. Refusal to comply leads to disqualification as a Local Governor. Local Governors will not be allowed to take up their duties until DBS clearance has been secured. Local Governors are also required to confirm that they have read the most up-to-date version of the DfE guidance 'Keeping Children Safe in Education'

All Local Governors are required to say that they have read and will honour the Sigma Code of Conduct for Members of a Local Governance committee and accept the seven Nolan Principles.

The criteria for being a Local Governor of a Sigma Academy is as follows: -

- Agreement with and a commitment to help deliver the Mission, Vision & Values of the Sigma Trust
- A willingness to serve as a member of the Governance Committee under the Sigma Scheme of Delegation for Local Governance Committees
- A willingness to agree to and abide by the Sigma Code of Conduct and the seven Nolan Principles of Public Life (Selflessness, Integrity, Objectivity, Accountability, Openness, Honesty, Leadership)
- Proof of identity and clearance under a DBS (Disclosure & Barring service) check
- A commitment to raising aspirations, expectations and standards of progress and achievement in the relevant Academy
- A commitment to being available to attend relevant meetings and workings of the Governance Committee, and to undertake training which will assist Local Governors in fulfilling their duties as effectively as possible
- A willingness to contribute specific skills, knowledge and/or experience to help the school provide the best possible education for its pupils
- A commitment to promote and support equal opportunities for all members of the school community
- A commitment to work to ensure the safety and well-being of the children in our care
